GOLF COURSE COMMITTEE UPDATE

The golf course was sold to Kingwood FLOG Properties. It hopes to develop the golf course into a small gated community. We sued the developer and our attorneys are working to obtain the best possible result for us. Our understanding of the current situation is that the developer is still working with the Harris County Flood Control District on its drainage plan. If you have concerns regarding the upkeep of the golf course, please call the City of Houston's 311 number and let them know. You will need the property address which is 805 Hamblen Road; the 311 operator will give you an incident number to reference for follow up. You may also call Ron Holley at 281-812-2700 to voice your concerns. And you may contact our Councilman Dave Martin at 832-393-3008, refer to your incident number when contacting the Councilman's office.

It is important to note that the community nor the FCPOA have any authority over the golf course.

TREE WASTE AND JUNK WASTE PROGRAM

On the 2nd Wednesday of the month, residents may dispose of their Tree Waste and Junk Waste at the curbside. Tree Waste is collected during ODD numbered months and Junk Waste is collected during EVEN numbered months. Junk Waste may NOT be placed for collection during a Tree Waste month. Trash may be put out between the hours of 6:00 p.m. the Friday before and 7:00 a.m. on the scheduled collection day.

Tree Waste months are January, March, May, July, September, and November.

TOWNHOMES ON MARINA DRIVE

We received correspondence from the Harris County Flood Control District this week.

The last three townhomes have completed the condemnation process. One of the townhomes is scheduled to be torn down on July 5, 2022. The second townhome is scheduled to be torn down on July 14, 2022. A payment for the third townhome has been scheduled and it will be torn down in the near future.

FCPOA is looking into leasing some of the property from the Harris County Flood Control District to create more green space for our residents to use.

FOREST COVE POOL

The Forest Cove Pool, located at 1025 Marina Drive is open. Hours for the pool are Noon to 8:00 pm Tuesday through Sunday, closed Monday for maintenance. On "holiday" Mondays, the pool will remain open and close on Tuesday for maintenance. All residents that have paid their association fees may use the pool. The Board will be adding some shade tents on the south side. There are Port-o-cans and a hand washing station on location. A reminder to bring your own chair. We have been working hard to keep the pool functioning amid the chronic vandalism since Hurricane Harvey destroyed the townhomes around the pool, we plan to provide a better environment next year with the removal of the remaining destroyed properties.
